Location

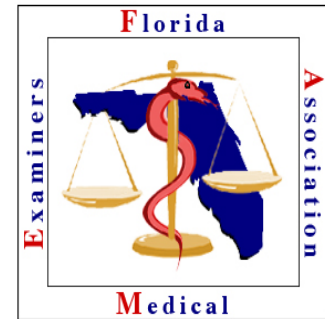
